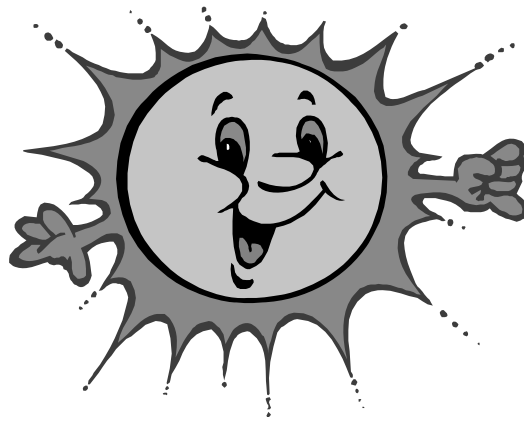

- Space is limited, therefore, registration is on a first-come, first served basis by advance payment. We cannot guarantee a seat if registration does not reach the Association office by the deadline.

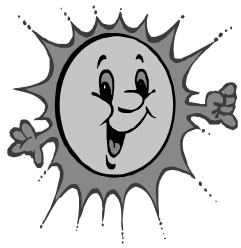
## CANCELLATION POLICY
